Business Programs Overview

1) Quebec Investor Program

 the only program offering Canadian PR in exchange for a passive five-year term investment of C\$1,200,000

2) Provincial Nominee programs

- more popular programs to attract business people to Canada
- focus on stimulating Canadian economy and creating jobs in Canada
- Provinces with their own business/entrepreneur streams:
- Manitoba- min 150K-200K
- Saskatchewan 200-300K
- Nova Scotia Entrepreneur 150k min
- New Brunswick Entrepreneur 250K
- BC PNP 3 business streams with 100k min
- Ontario 200k-600k investment

3) Start-Up Visa program

for innovative start-ups to scale internationally



British Columbia Provincial Nominee Program (BC PNP)

- For high net worth business people who can invest in and actively manage a business in BC
- Point-based system; 3 Streams
- Applicants must also have the required personal and investment funds
- Options for corporations looking to expand into BC, which may also need to get permanent residency for key employees (up to 5)

BC PNP – Entrepreneur Base Program

Personal requirements

- a personal net worth of at least CAD\$600,000
 - Must obtain Verification Report from BC PNP qualified supplier
 - have basic English or French language proficiency at level CLB 4 or higher

Business and/or management experience

- three years of experience as an active business ownermanager OR
- four years of experience as a senior manager OR
- a combination of at least one year of experience as an active business owner-manager and at least two years of experience as a senior manager

BC PNP – Entrepreneur Base Program Cont'd

***** Business, job and investment requirements

- own at least one-third (33.3 per cent) of the business in BC
- If proposed ownership is less than 33.3 per cent, must invest a minimum of \$1 million in an equity purchase.
- establish an eligible new business or purchase and improve an existing business
- make an eligible personal investment of at least CAD\$200,000 in the business
- create at least one new full-time job for a Canadian citizen or permanent resident in the business
- provide active and on-going participation in the day-to-day management and direction of the business

BC PNP ENTREPRENEUR IMMIGRATION PROCESS





BC PNP - REGIONAL PILOT STREAM

New pilot for Entrepreneurs wishing to start a business and settle in a regional community (population under 75,000)

Requirements

- conduct an exploratory community visit and present their business plan
- have a minimum personal net worth of \$300,000
- have a minimum of \$100,000 CAD in eligible business investments
- have a minimum of 51% ownership in the business; and
- create at least one new job in the local community

The Start Up Visa Program

- For innovative young companies and their entrepreneurs
- Canadian Government Approved Designated Entities are able to provide access to:
 - an expedited immigration process specifically for start-up entrepreneurs
 - expedited immigration process for foreign owned businesses looking to operate in Canada
 - up to five (5) founders can apply
- Candidates must meet all program criteria



The Start Up Visa Program – Cont'd

Individual Criteria

- Successful and proven entrepreneur
- Level 5 English or French language requirement
- Clean criminal and medical records
- Completed at least one year of post-secondary education
- Sufficient settlement funds as per IRCC
- Letter of Support from a Designated Entity
- Must own at least 10% of the qualifying business

The Start Up Visa Program – Cont'd

Business Criteria for the Company

- Has been incorporated or is planning to incorporate in Canada
- Investment qualification
- Business Plan designed and supported by Designated Entity
 (industry & competitor analysis and investment, a well-developed
 market, financial and company growth strategy)
- Demonstrate market validation for the product/service
- The business has reasonable potential for solid financial returns
